Research Scholar, Council of the Humanities and Lecturer, Department of Economics Princeton University

Thomas C. Leonard is an historian of economics at Princeton University, where he is a Research Scholar in the Humanities Council, and a Lecturer in the Department of Economics. Princeton has twice awarded him the Richard D. Quandt Prize for teaching excellence, and he has taught a generation of Princeton students to understand economic ideas in their historical, legal, and ethical contexts.

Professor Leonard is a leading scholarly authority on American economic life during the late 19th and early 20th centuries — its participants, theorists, and regulators. He is best known for his book, *Illiberal Reformers: Race, Eugenics and American Economics in the Progressive Era.* In 2017, the History of Economics Society awarded *Illiberal Reformers* the Joseph J. Spengler Prize for book of the year. *Illiberal Reformers* has been reviewed by *The New York Times, The Washington Post, The Wall Street Journal, Bloomberg View,* and *The New Republic,* and by more than forty other general interest and scholarly journals.




