CALL FOR PAPERS

Submission Deadline: February 16, 2024

SUBMISSION GUIDELINES:

- Submissions can be full-length manuscripts, short summary notes, or abstracts. Only full-length manuscripts and summary notes will be considered for inclusion in the special issue of the *ITJ*.
 - Full-length manuscripts should not exceed 8,000 words and should be no longer than 30 double-spaced pages using standard margins, a 12-point font, and including the cover page, all references, tables, and graphs.
 - Summary notes should not exceed 3,000 words and should be no longer than 12 double-spaced pages using standard margins, a 12-point font, and including the cover page, all references, and tables. Please refrain from including figures in the summary notes.
 - $\circ~$ Abstracts should be between 100 and 500 words.
- Submissions are invited on any topic related to global business issues including, but not limited to, accounting, economics, finance, foreign direct investment, globalization, information technology, investment, logistics, management, marketing, sustainability, trade, and development.
- All participants must submit their work electronically to <u>cswht@tamiu.edu</u>.
- Submissions imply that at least one author will register for the Conference and be present at the time designated in the Conference program, either in-person or virtually. Research-in-progress will be accepted. Graduate students and non-academic affiliates are also welcome.
- Please send an **MS Word file** of your submission by **February 16, 2024** for inclusion in the Conference. Each submission must include a cover page containing only the title of the research with the author(s) name, affiliation, and contact information.
- All submissions must include the following statement:

"By submitting this paper/summary note/abstract, I acknowledge that I am the author of the submission and that I have the permission of all co-authors to include this paper/summary note/abstract in the 28th Annual Western Hemispheric Trade Conference Proceedings. I also acknowledge that I have the rights to include any third-party materials in the submission."

- Upon submission, please indicate:
 - if you would like your full paper or abstract only to be considered for inclusion in the electronic proceedings,
 - if you would like your submission to be considered for publication in *The International Trade Journal*,
 - if you would like your submission to be considered for the Center's Working Paper Series,
 - if you prefer to make your presentation in English or Spanish, and
 - if you plan to participate in person or virtually.

CONFERENCE FORMAT:

- Day 1 (Wednesday) | In-person evening keynote address; virtual concurrent academic sessions will be added, if needed.
- Day 2 (Thursday) | In-person full-day Conference with concurrent academic sessions, a luncheon keynote address, and dinner; virtual concurrent academic sessions will be added, if needed.
- Day 3 (Friday) | Virtual half-day Conference with concurrent academic sessions, a keynote address, and presentation of student awards.
