## DANIEL T. GRISWOLD ADJUNCT SCHOLAR, CATO INSTITUTE



**Daniel Griswold** is an adjunct scholar at the Cato Institute specializing in trade and immigration policy. Griswold is a former director of the Center for Trade Policy Studies at Cato and former co-director of the trade and immigration project at the Mercatus Center at George Mason University. From 2012 to 2016, he served as president of the National Association of Foreign-Trade Zones.

Griswold is the author of the 2009 Cato Institute book, *Mad about Trade: Why Main Street America Should Embrace Globalization*. He has also authored numerous studies on immigration and trade; testified before congressional committees; commented for CNBC, CSPAN, Fox News, and other TV and radio outlets; and written articles for *The Wall Street Journal*, *The Los Angeles Times*, and other publications. Griswold holds a bachelor's degree in journalism from the University of Wisconsin at Madison and a master's degree in the Politics of the World Economy from the London School of Economics and Political Science.
